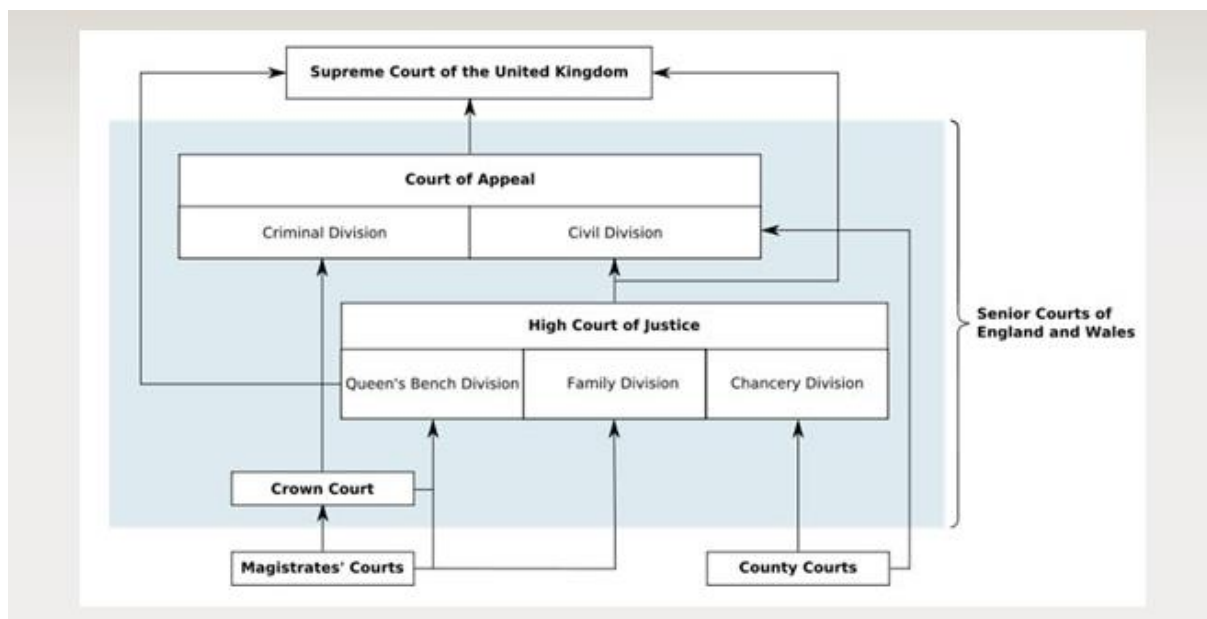


Year 12 BTEC Extended Certificate in Applied Law Summer Independent Learning 2021
