<u> Task 1 – Murder Scenario</u>

Complete the below scenario in full.

Albert stole £20,000 from Mark during an armed robbery. Mark wants to scare Albert into repaying the money so decides to cause a small explosion in Albert's garage. He thinks that the explosion will show Albert that Mark is not to be messed with. He goes into the garage and plants a small homemade bomb under the car. The bomb is timed to go off at 7am as Mark knows Albert leaves for work at 7:30am.The next morning Albert needs to go to work early so he goes into the garage just before 7am and starts his car. The bomb goes off and Albert is instantly killed. Mark is annoyed as he hasn't got his £20,000 back, so he decides that he is going to kill Albert's wife Claire instead as revenge. He goes to their house late at night with a knife and sees a shape in the living room on the sofa. He stabs at the shape ten times thinking that he is killing Claire, but unfortunately it is Albert's sister Jenny instead. She is taken to hospital and is told that she can survive if she has a blood transfusion. However, her religious beliefs forbid it, so she dies later that die.

Advise whether Mark will be liable for the homicide of Albert and Jenny.
