Task 1 – Murder Scenario

Complete the below scenario in full.

Stefan and Theo work together. Stefan knows that his wife, Dorothy, is having an affair with Theo. When Stefan and Dorothy are having an argument he tells her that he knows about Theo. Stefan pulls out a knife from his pocket and waves it in front of Dorothy's face, intending to scare her. He trips up whilst doing it and stabs Dorothy in the stomach once. She is taken to hospital. Whilst there she receives poor medical treatment from Dr Singh as he is tired from working a 20 hour shift. The next day she suffers a heart attack due to her injuries and dies.

Advise whether Stefan is liable using the laws on homicide
